

Attorney General Holder is Out of Control

Failed to fulfill oath of office - Holder's Justice Department has failed to investigate and prosecute any IRS officials for targeting conservative groups who sought tax-exempt status.

Perjury - Holder signed off on the Department of Justice's (DOJ) wide-ranging search warrant for private emails and communications surveillance of Fox News reporter James Rosen and then lied to Congress about it.

Perjury and obstruction of justice - Holder failed to turn over documents related to Operation Fast and Furious, the botched "gunwalking" operation that sent thousands of guns from the U.S. to drug cartels in Mexico. The guns were used to kill hundreds in Mexico and U.S. Border Patrol agent, Brian Terry. Holder also misled Congress about how much he knew about Fast and Furious and when he learned it.

AMMO ACT

- Federal agencies are stockpiling HUGE amounts of small arms ammunition - local law enforcement agencies are forced to cut weapons training or pay high prices in open market.
- H.R. 1764, the Ammunition Management for More Obtainability (AMMO) Act of 2013 - would restrict government agencies – except Defense - from buying or possessing any more ammunition each month than the monthly average it purchased between 2001 and 2009.
- The bill would also require the Government Accountability Office (GAO) to conduct a report on the government's ammunition purchases and their effect on the ammunition supply available to the public.

Olson bill, H.R. 1280, the Voter Fraud Prevention Act – stiffens penalties for individuals convicted of voter fraud or tampering with official election materials, i.e. voter registration cards or absentee ballots. The bill also increases the jail sentence from 5 - 10 years, and anyone convicted of either of these two offenses permanently loses their right to vote in federal elections.

OBAMACARE IS A TRAIN WRECK

- "Senator Max Baucus, D-MT, the leading force who pushed Obamacare through the Senate, said this on April 17, 2013: "I just see a huge train wreck coming down." He's right.



EXAMPLES OF THE OBAMACARE TRAIN WRECK

- Registration for the Federal Exchange to be used by Texans starts on October 1, 2013. Do you know how to enroll?
- The Federal Exchange takes control of healthcare for Texans in the Exchange on January 1, 2014? Do you know what your health care will be on January 1, 2014?
- For the first time in federal law, Obamacare defines a "full time employee" as someone who works 30 hours or more per week. Is your business planning to limit some employees to less than 30 hours per week to avoid Obamacares' costly mandates?

Defund Obamacare

- **The House has voted 40 different times to partially or fully repeal or defund Obamacare.**
- **The Senate has done nothing.**
- **Conservative Senators need to force Harry Reid to consider legislation to defund or delay Obamacare.**
- **The House can't do the Senate's job.**

Obamacare Not Touched By Government Shutdown

- **Congress allocated zero funds for Obamacare this fiscal year. Yet, Secretary Sebelius has been able to spend \$1 billion on implementation by transferring funds within HHS.**
- **Shutting down the government will not defund Obamacare.**
- **I'm a cosponsor of the Cruz/Graves bill to fully defund Obamacare.**

NSA Surveillance

- **We must be ever vigilant over our Constitutional Rights.**
- **Terrorists still want to kill us.**
- **We need the appropriate balance between national security and privacy protections.**
- **Congress needs more oversight of these programs to ensure that the laws are obeyed.**
- **The House Intelligence Committee continues it's investigation.**

Immigration Reform

- A step-by-step approach will make sure we avoid mistakes of the past.
- The critical first step must be to establish border security and enforce our immigration laws.
- Then we must fix our visa program - 40% of illegal immigration is overstayed visas.
- We must also establish a working and reliable E-verify system.

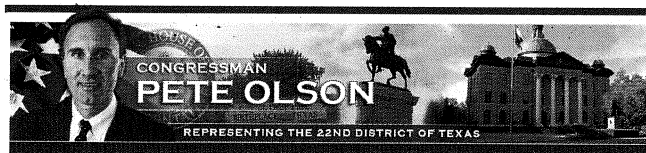
Undocumented Children
